They perform a range of mainly routine tasks using limited practical skills and fundamental operational knowledge in a defined context. 	<p><b>CUA30320 Certificate III in Assistant Dance Teaching</b></p> <p>This qualification is delivered by agreement with ATOD RTO Code 31624 <a href="https://www.atod.net.au/">https://www.atod.net.au/</a></p> <p>Available to Year 11 students.</p> <p>This qualification reflects the role of individuals working in varied contexts in the dance teaching industry, providing aid and support to teachers and students under supervision. Individuals are expected to use some discretion and judgement and relevant theoretical knowledge to assist in instructing, managing, and planning classroom activities. The job roles that relate to this qualification may include assistant dance teacher for 5 to 10 year old children.</p> <p>Students will be required to assist dance teachers in classes both at school and externally through their Dance School. Students will refine their dance techniques in commercial and contemporary genres; develop music ideas and listening skills that will be applied to the role and expectations of assistant dance teachers. This will be achieved through studying teaching theory, behavioural psychology, ethical instruction, anatomy and nutrition, dance composition and analysis skills. Students require technical proficiency in at least one genre and a basic awareness of a second. Individuals complete tasks with limited complexity and with required actions clearly defined. Job roles that relate to this qualification may include Venue Attendant, Usher, Production Assistant (Film and Television), Junior Production Crew, Trainee Production Crew, Radio Production Assistant, Program Seller, Merchandise Seller, Stagehand, Runner, Dresser, Crewing Employee, Sound Assistant, Bump in/Bump out Loader, Wardrobe Assistant. This qualification reflects the role of individuals who apply the skills and knowledge to conduct pre-planned coaching sessions with foundation level participants in a specific sport. This qualification provides a pathway to work in assistant coaching roles working or volunteering at community-based sports clubs and organisations in the Australian sport industry. Individuals with this qualification use a defined and limited range of basic coaching skills to engage participants in a specific sport and are involved in mainly routine and repetitive tasks using limited practical skills and basic sport industry knowledge. They work under the supervision of a coach. Possible job role titles depend on the specific sport may include assistant coach.
